## Award Guidelines

### I. Awards Purpose

The Seventh-day Adventist Church and Philanthropic Service for Institutions sponsors an awards program to honor individuals who have displayed exemplary commitment to Adventist institutions. The Adventist Philanthropy Service Awards recognize those who have exhibited visionary commitment by partnering with organizations through their resources to establish a stronger sense of service to God and their community.

PSI and the Adventist Church desire to pay tribute to volunteers who inspire and encourage service in their communities through their strong commitment to the vision and mission of Adventist institutions and the lives they influence.

We seek nominees who inspire greatness in the institutions with whom they work and who demonstrate an exceptional commitment to philanthropy through their actions.

### II. Selection Process

The Awards will recognize the outstanding service, volunteerism and generosity in **K-12 education, higher education, healthcare, and supporting ministries**. Awards are presented at PSI's Conference on Philanthropy, and honorees must be present to receive the award. The PSI Advisory Committee, which is representative of the types of organizations within the North American Division, will select the award recipients from among the nominees who meet the criteria.

### III. Criteria for Nomination

The awards are presented to an individual or family with a proven record of volunteerism and/or generosity who, through direct financial support or sacrificial giving, demonstrates a Biblical model of stewardship and philanthropy. Your nomination should include evidence of superlative philanthropic service and/or volunteerism.

## Examples:

- A description how the nominee's philanthropic giving was exhibited by giving time, energy, financial resources and service.
- The impact of the nominee's philanthropic involvement on the institution and those it serves.
- Specifics on how the nominee modeled or encouraged others to support the institution.
- Examples of outstanding service within the community and/or service on boards or committees.
- Examples of how the nominee's service encouraged civic responsibility or provided valuable assistance so that institutional money could be spent on other valuable initiatives.

## IV. Call for Nominations

If you know a person or family who exemplifies this special kind of service in Adventist philanthropy, we encourage you to bring them to our attention by completing the enclosed nomination form. ***Nominations are due to PSI no later than May 10, 2018.*** In addition, your CEO, president, or committee chairperson must indicate concurrence with the nomination by signing the nomination form.

The following areas are weighed as indicated.

1. Evidence of consistent, regular and/or substantial gift support to your organization and its impact. (30%)
2. Evidence of consistent, regular and/or substantial volunteerism to your organization and its impact. (20%)
3. Accounts of how the nominee's philanthropic service influenced the institution (30%)
4. Evidence of outstanding leadership in the community and/or on committees or boards (20%)
