Milton Murray Trailblazer In Philanthropy

Award Guidelines

I. Awards Purpose

The North American Division of Seventh-day Adventists, through Philanthropic Service for Institutions, sponsors an awards program to identify and recognize achievements by professional fundraisers who have exhibited creativity, initiative, and consistent professional service on behalf of Adventist philanthropy in its institutions by professional practice in fundraising. Such an individual helps his or her institution form vital partnerships with those who financially support the institution's mission through philanthropy.

II. Selection Process

Nominations for the award may be placed by the nominee's peers or an institutional executive. Each person submitting a form is limited to one nomination. Criteria for the nominations are listed below.

Names supplied with the appropriate qualifications will be submitted to the Milton Murray Trailblazer Award Committee for selection of the award recipient.

III. Criteria for Nomination

The award is designed to recognize an outstanding individual whose career as a staff executive has been exemplary, results oriented, and inspiring. Your nomination should cover the following:

- Length and tenure of fundraising background and experience (to include at least five years of fundraising experience);
- Examples of qualities such as integrity, initiative, enthusiasm and creativity;
- Evidence of a deep commitment to personal volunteerism and to continued professional growth as reflected in participation in conferences, articles published, speeches presented about the advancement of philanthropy, fundraising and credentialing;

- Examples of personal efforts to promote philanthropy to others interested in the field, including serving as a mentor to those less experienced;
- Participation, collegiality and collaboration with other nonprofit organizations; and
- Performance which has consistently excelled in a particular area of philanthropic endeavors among Adventist organizations and institutions.

IV. Call for Nominations

Return completed nominations to LorenaHernandez@nadadventist.org. **Nominations are due to PSI no later than May 31, 2018** In addition, your CEO, president, or committee chairperson, must indicate concurrence with the nomination by completing the endorsement section on the nominating ballot.

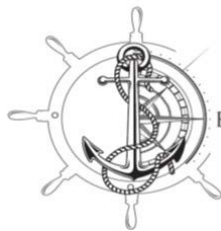
